Finance and Personnel Committee

The budget was discussed and determined to be doing well. The bank balances were discussed. The overtime breakdowns were gone over, and noted that they have increased in line with the recent salary increases.

The interest on the redevelopment account was discussed. It was noted that the rate dropped from 4.4% to 3.25%. It was recommended to conduct a study of excess funds to look for better rates, perhaps suing CDs.

Facilities and Tenant Relations Committee

The Committee discussed bids that were opened. The KITCHEN AND BATHROOM REPLACEMENTS AND PLUMBING IMOROVEMENTS AT EASTSIDE GARDENS was over cost estimates and we are recommending that we reject the bids and re-advertise.

The REPLACEMENT OF BATHTUBS AT CONSTABLE HOOK VILLAGE (12-7) AND KILL VAN KULL GARDENS ANNEX was over cost estimates for the third time so we are recommending rejecting the bids and following regulations that allow for the job to be negotiated. After this report we would like Paul to give a brief over view of that process as we have not had to do it for 30 years.

We reviewed the roof replacement for 30 East 50 St. The low bidder withdrew his bid for calculation errors. We had concerns the bid was too low anyway. The second low bid was within the cost estimate and we are recommending to award that bid.

You have draft copies of the "What makes me Happy" calendars, please give them a look as we would like to get them to the printer by the end of the week. Mike Olesky did a great job organizing what we asked and the kids did an even better job with their artwork.

We also discussed the possibility of recognizing notable past and present tenants and will continue that discussion and bring any finished ideas to the board. We also briefly discussed the possibility of partnering with the Board of Ed to possible paint an outdoor mural at one of our properties. HUD has changed scoring criteria on properties in relation to such activities so it is worth exploring. Thanks to Commissioner Makowski as we made him an initial point of contact (the director volunteered him).
