Each month, the Firm will submit a detailed bill for services rendered. The Firm understands and agrees that the fixed price in this proposal will not be a guarantee of payment, but rather the maximum which the BHA will pay for the work listed under “Tenancy Legal Services” as reflected by actual hours worked up to the proposed amount with no additional compensation for going over the proposed amount.

The cost proposed (\$160 hours with anticipated 1,200 hours per year) is a “not-to-exceed lump sum proposal and hourly rate” that will be billed off the not-to-exceed lump sum proposal.
