#### **Finance and Personnel Committee**

Reviewed the monthly finance statements. Our revenues are in excess of our budget, about \$650,000. Our expenditures below our budget by \$400,000.

The bank balances and the interest were reviewed. The interest is doing well and the bank balances dropped for the month. There was a large payment for pensions.

For the month of February, the payroll is pretty consistent. It's actually a little on the lower side, but it's only 29 days.

The payroll was discussed and it will be requested that in the future, overtime is reported in hours per employee.

Finally, the bill list was reviewed.

#### **Facilities and Tenant Relations Committee**

The Building and Grounds and Tenant Services Committee met and discussed the following highlighted by required changes to the HCV Administrative Plan as a result of HOTMA.

The regular extermination and bed bug extermination contracts are expiring with an option for a one year renewal. Due to the consistent and good service provided by the current contractors we are recommending extending the services for the additional year.

Bids were opened for Apartment Turnover Painting and Plastering were opened and pending legal review, we are recommending an award to A&A Painting and Contracting. Should there be a problem with the low bid it is recommended that the project be re-bid as there is a significant difference in cost with the 2nd low bid.

We are recommending rescinding the two contracts to Pelligrino for 4 vehicles. Pelligrino has informed us that they are unable to obtain the vehicles they bid for. United Ford has confirmed they would be able to honor their bids. Due diligence research by BHA maintenance staff indicated that the prices for the vehicles bid by United Ford are within cost estimates on the vehicles. We are further recommending that United Ford then be awarded the contract for the vehicles.

There are significant changes to both the HCV and Public Housing programs as a result of HOTMA (Housing Opportunity Through Modernization Act).

While the Act was passed in 2016, the regulations have been being drafted since then. The changes are due to go into effect in January 2025, contingent upon the HUD computer systems being ready and working, but the changes to policies and plans needs to be worked on now as per HUD.

Hernan went over the changes to the Administrative Plan for the HCV program and we will be going over the Public Housing Program next month.

The highlights of the changes are as follows:

- The definition of income and associated exclusions including student financial assistance
- Calculating income from assets
- The information needed for the calculation of income including self-certifications
- Procedures for the documenting excluded income
- Interim income reexaminations
- Income determination from other programs
- Elimination of the Earned Income Disregard
- Mandatory deductions
- Changes to health and medical expense deduction
- Hardship extensions
- Child care deductions
- Limitation on Assets
- Exclusion from Assets

Staff has taken some initial training on certain provisions but needs additional training now that the final regulations are being released. The new training not only incudes case workers, but support and supervisory staff. It is recommended that the budget for training be increased in the upcoming budget proposal
