Finance and Personnel Committee

The committee reviewed the materials presented. The budget to actuals, interest and rates, and overtime were reported on and discussed.

The committee reviewed the monthly reports and found them to be consistent with prior months. The committee discussed the retro pay that the staff was to receive along with the wage study being conducted. The redevelopment class scheduling was discussed. Finally, the Legal contract moving forward was discussed.

Facilities and Tenant Relations Committee

Rejecting two bid and rebidding, A Bid for Bathtub Replacements at Constable Hook Village (12-7) and Kill Van Kull Gardens Annex (12-7A) and a Bid for Kitchen and Bath Replacements and Plumbing Upgrades at Eastside Gardens (12-6B). Both bids were over cost estimates. The Director asked the attorney to research the conditions under which a project can be negotiated as this is the second time the Eastside bids came over cost estimates and we are waiting for that answer.

Recommending to award a contract to GM Builders Group for Exterior Panel Improvements at Back Bay Gardens. Since the meeting and when the packets were sent out further communication was had with the contractor based on some financial concerns, but the bidder responded in writing that they understood and would follow the procedures established by BHA. Staff and professionals will monitor financial submissions and requisitions closely.

We will be honoring our NAHRO award winners, Sal and Lee for their Sing-A-Long program and Akayla for her winning poster and being selected for the NAHRO "What Home Means To Me" 2025 calendar. It was recommended that we match the \$100 Akayla will be receiving from

NAHRO and also recognize Sal and Lee with \$100 gift cards. BHA also purchased and new Karaoke machine for the Sing A Longs which we will present to Sal and Lee for the residents use. Mike Olesky selected "What makes me happy" as the topic for the BHA poster contest. The children were a little slow getting the posters to him so we may not have them tonight.

Staff tried to get a couple of cars moved in the back of 21st street to assist the garbage trucks. It was found that apparently the building in back of 21st st may be renting spaces. Upon further investigation, it was discovered that the spaces being used by the private building may be in fact BHA property. After discussions with the director we are recommending that a survey be done to establish legal property lines.
