## **Finance and Personnel Committee**

The committee reviewed the regular financial reports and found them in order. Everything was found to be consistent with previous months, including overtime reports, accounts, and interest. The development fund is dropping due to purchasing a property.

## **Facilities and Tenant Relations Committee**

The Committee met on Friday November 7th. We reviewed the 15 bids and one proposal that were opened on Thursday November 6th. We are recommending the submissions, which were supplied in your packets for review, except for the following:

No submissions were received for the pumps. Maintenance will market the request and we will rebid.

The generators submissions were not acceptable. Non-equal product was submitted, wattage specifications were not followed and generators were missing. We are recommending rejecting the bids and rebidding. Without generators to install, we are recommending that we hold the installation bid until we secure the generators.

This is new. A problem was discovered with the washing machine bid. The models were not as specified and one bid included machines that had card readers instead of the adaptability to tokens. We are recommending throwing out the bids and reworking the specifications to accommodate the issues encountered.

While recommending an award the low bidder for the peaked roof asked to withdraw his bid as they made errors and the low bidder for the Back Bay kitchen and the lobby flooring job, the same bidder, Master Build, failed to list subcontractors which is a fatal bidding error and their bids had to be rejected.

We received the keys to the Assumption property. We have assumed the fence lease and looking to further secure the facilities with additional fencing and cameras. We secured a firm to clean the property from overgrowth and board the windows and paint to match the building. We want to be good neighbors. We plan to have the exterminator inspect the property, inside and out, and conduct any necessary remediation or preemptive activity.

#### **Executive Director John Mahon:**

Mr. Chairman, I just want to make one quick comment. Got to give Evan a lot of credit. These are an awful lot of bid openings that we did in one day and it was 16, basically, in one day and he coordinated it and put it all together and has everything. He just got us through this. There were other people, Hernan and his staff also came in and chipped in downstairs, coordinating the folks coming in. But I just want to recognize that, because it was very unusual for us to do that much and it pretty much went on without any hitches and it's thanks to the hard work of everybody. So thank you, Evan. It was really good.

## **Chair Lombardo:**

Now, I'm done with the regular order of business and turn the meeting over to your attention.

## **Chair Lombardo:**

Before I turn over for the public portion of this. Evan, thank you. And I would be remiss if I didn't also acknowledge when these bids come in and the timing, the work of our legal counsel as well. So thank you Andrew for doing that. It's time for the public session. Would anybody like to speak?

#### Mr. Betancourt:

Yes.

#### **Chair Lombardo:**

As we've mentioned before, you have three minutes and feel free. Welcome Mr. Betancourt.

#### Mr. Betancourt:

Thank you. First, I'm going to submit to the record, two packets. Well, same thing but one for the council.

## **Chair Lombardo:**

You can leave them both with the council.

#### **Mr. Betancourt:**

Okay.

#### **Chair Lombardo:**

Thank you.

# **Mr. Betancourt:**

Yep. All right. My name is Alberto Betancourt. I live in 49 East 18 Street, apartment 323. In your own reasonable accommodation policy, the Housing Authority designates Hernan Bracero as the section 504 coordinator, responsible for handling ADA section 504 and accommodation requests.

On August 20th, I submitted a reasonable accommodation request supported by medical documentation. The authority acknowledged the request in writing and directed me to contact Mr. Bracero. I complied. The request was submitted multiple times, including by certified mail and hand delivery.

Mr. Bracero never contacted me. No interactive process has ever occurred. Despite having the request, the verification, and the designated coordinator, the Housing Authority issued a denial. The denial was made without any discussion, without any clarification request, and without the interactive process required under the ADA section 504 and Fair Housing Act. The board is now formally on notice of noncompliance with its own published ADA 504 policy and federal law.
