Members of the Board:

Resolution authorizing the acceptance of the minutes of the board of commissioners regular meeting held on April 20, 2021.

HUD announced waivers that PHAs can employ in response to the COVID-19 crisis. We would like to avail ourselves of any possible waiver that can apply to our programs. It does not mean that we have to employ those waivers, but it allows us to rain the option and maintain flexibility. HUD periodically updates said waivers. The Assistant Executive Director will briefly discuss the latest information. A Resolution designating the waivers we may use is being prepared for your consideration.

BHA performs inspection services for Jersey City Housing for properties where a conflict of interest prevent Jersey City Housing from performing such inspections. We have had this cooperative agreement for many years. A Resolution authorizing the Executive Director to effectuate the renewal of the interlocal agreement between the Jersey City Housing Authority and the Bayonne Housing Authority to perform Housing Quality Standard inspections is being prepared for your consideration.

BHA has a Congregate Housing Grant from the State that provides in home services with the goal of keeping residents in their homes as opposed to other institutional options. A resolution with the NJ Department of Human Services (DHS) in regards to the Congregate Housing

Grant indicating that the BHA will not receive or share any personal health information is being prepared for your consideration.

The Bayonne Housing Authority has once again partnered with Bayonne Medical Center for the purpose of offering COVID-19 vaccinations. This time vaccines are being offered at the family sites. We are about midway through the program. The vaccines clinics are being offered outdoors, weather permitting, to be highly visible as BMC is also hoping some in the adjoining neighborhood residents avail themselves of the opportunity to be vaccinated. There has been an average of 3-6 people per day which in light of the availability of vaccines, is considered successful.

The Bayonne Economic Opportunity Foundation (BEOF) received a donation of over 200 new vacuum cleaners. The BEOF graciously earmarked a majority of those vacuum cleaners for BHA family residents. A computer based sign up, while supplies last, is underway with the delivery to apartments anticipated in the next couple of weeks once BHA verifies the list.
