### **SCOPE**

The Housing Authority of the City of Bayonne (the "Authority") is seeking bids for the below listed laundry machines or equivalents. The Authority is seeking a total of sixteen (16) laundry machines.

#### DESCRIPTION

Eight (8) Speed Queen Washers model #SCT030 or equivalent.

Eight (8) Speed Queen Dryers model #ST030 or equivalent.

#### REQUIREMENTS OF THE VENDOR

The Vendor must be a franchised and/or authorized factory representative, able to furnish the specified machines. Dealers or agents submitting a Quote may be required to submit a letter of certification from the manufacturer whose product is proposed, certifying that they are authorized by the manufacturer to supply the vehicle specified.
