The Chairman opened the floor to anyone in the audience. No response.

**Kathleen Walrod:** Mr. Aziz, the question is if you want to address the board. You can have a seat Mr. Aziz. Mr. Aziz has written up his appeal to the board. He's saying that he's resided in an apartment located at 535 Avenue A since 2003. He suffers from medical conditions such as COPD and congestive heart failures which are aggravated by fumes from his kitchen and that he coughs, wheezes, and has shortness of breath. He applied requesting a transfer for a 1 bedroom apartment. The Housing Authority approved him a transfer for a 1 bedroom apartment and put him on a waiting list. On June 15, 2017, he was sent a letter that he would be transferred to a 1 bedroom unit at 30 East 50<sup>th</sup> Street. He has a hard situation that prevented him from transferring him to that location for certain reasons being that he doesn't drive and that some people living close to him in the same building at 535 Avenue A maintain his needs. The offered apartment is far from his daily activities. His church is at 13<sup>th</sup> Street and is more available than at 50<sup>th</sup> Street. Also psychic and emotional reasons concerning him. At the same time, after the offered apartment he met with Suky Albizu directly and explained the situation and she did not tell him that he was not eligible for another apartment. He then met with Mr. Pacyna who gave him a form to be filled out and that was the request for reasonable accommodation. Nobody told him that he was not eligible for another apartment. So regarding the medical condition and personal circumstances, he requests a transfer to a 1 bedroom apartment in the same building, 535 Avenue A. For the record I would note that there was both an informal and a formal hearing in this matter. The formal hearing was by an independent hearing officer who found that Mr. Farag Aziz did not sustain his burden of showing the Housing Authority acted in an improper manner or in an arbitrary manner in that the regulations of the Housing Authority as well as HUD only allow one apartment to be offered and if that apartment is refused, then the applicant has waived their right to have another transfer. So under the HUD and Housing Authority Rules and Regulations, there is no right to request a specific apartment. There is no likelihood that a 1 bedroom apartment in that building will become available. Once you've passed on the apartment, you've given up your right to a transfer at that point. That is the written opinion of the hearing officer. So I leave the matter to the board.

**Chairman Nolfo:** So let me reiterate in layman's language to try to understand. Maybe you can try to speak for yourself. You're looking for another apartment due to your situation and right now there's nothing available.

**Director, John Mahon:** We offered one already.

**Chairman Nolfo:** So we offered one to you, for your convenience. But you didn't want to because you wanted to be in the same building. Why are you here today, specifically?

**Kathleen Walrod:** He's here to appeal the hearing officer's decision.

**Mr. Aziz:** We have been in this building since 15 years. I have some persons close to me who help me. They drive me to the church because I don't drive. This location is far from this. They are beside me. Also food shopping and all my daily activities are easy to get to.

**Chairman Nolfo:** I understand but an apartment has already been offered and for whatever reasons, you did not accept.

**Kathleen Walrod:** Under the regulations, once he turns down the apartment there is not the possibility of offering him another apartment. And in our meeting he's indicated that even if we were to offer him another 1 bedroom apartment, he wouldn't accept it unless it were in his current

building. We can't guarantee anyone an apartment in a particular building. I would also note that when the offer was made on June 15<sup>th</sup>, Mr. Farag, and any other tenant is notified in writing that if he gives up that apartment, he will not be offered another one. He got that notice on June 15, 2017 as part of the offer.

**Chairman Nolfo:** All we can do at this time is say we will look into this and respond to you in writing with our decision.

**Mr. Aziz:** After the offer, I came here and made my concerns clear to Ms. Suky and Mr. Evan and Mr. Wilson and explained my situation. They gave me forms to fill out.

**Chairman Nolfo:** You have explained your situation. We have to review the matter and respond in writing. This is all I can say at the time. We can't make a final decision right now. Thank you for coming and addressing us.

Motion made by Commissioner Karczewski and seconded by Commissioner Moriarty to adjourn.

The meeting was then adjourned at 1:12 PM.
