In an effort to try and keep our legal cost down, I think that we can redo the proposals in a fashion that would reduce the possibility, you can never eliminate the possibility, but reduce the possibility of litigation because as it is presently written, as I indicated at caucus, it is problematic. It would just require us to redo the request for proposals, go back out to advertise, and maybe we can also do this online. It's my understanding that we don't do these online. And possibly get a better pool of submission than we've had this go-round.

Executive Director: That is a motion by Commissioner Patella. Is there a second?

WHEREAS, it is the conclusion of the Commissioners of the Authority that based upon the proposal submitted by Kathleen Walrod, Esq. of Secaucus, NJ to be the Authority's General Legal Counsel the selection of Kathleen Walrod, Esq. of Secaucus, NJ is in the best interest of the Authority; and

You're not splitting the atom with landlord/tenant by any stretch of the imagination. It's certainly not the most complicated area of practice. And with that in mind, I vote no.
