DECEMBER 31, 2022

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Business

The Company's business activity includes general construction including interior & exterior renovation work & metal fabrication for all types of commercial & governmental projects. Projects are primarily located in Northern New Jersey and the New York Tri-State region. The length of the contracts is typically less than one year. Operations commenced in 2014. The company was established as a limited liability company under the statutes of the State of New Jersey.

Management uses estimates and assumptions in preparing these financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

Date of Management Review

Management has evaluated subsequent events through March 04,2021, the date on which the financial statements were available to be issued.

Property, Equipment and Depreciation

Property and Equipment are stated at cost. Depreciation is being provided using accelerated and straight-line methods over the estimated useful lives of the respective assets, which is generally five to seven years.

Revenue and Cost Recognition

The Company recognizes revenues from fixed-price and modified fixed-price construction contracts upon the completion of each contract.

Contract costs include all direct material and labor costs and those indirect costs related to contract performance, such as indirect labor, supplies, tools, repairs, and depreciation. Selling, general, and administrative costs are charged to expense as incurred. Changes in job performance, job conditions, and estimated profitability may result in revisions to costs and income, which are recognized in the period in which the revisions are determined.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Cash Equivalents:

For the purposes of the statement of cash flows, the Company considers all highly liquid debt instruments with a maturity of three months or less to be cash equivalents.

Inventory:

Inventory is stated at lower of cost or market.

Contract Receivables:

Contract receivables are recorded when invoices are issued and are presented in the balance sheet net of allowance for doubtful accounts. Based on management's assessment of the credit history with customers having outstanding balances and current relationships with them, it has concluded that realization of losses on balances outstanding at year end will be immaterial. Contract receivables are written off when they are determined to be uncollectible. The allowance for doubtful accounts is estimated based on the Company's historical losses, the existing economic conditions in the construction industry, and the financial stability of its customers.

Income Tax:

The Company is not an income tax paying entity for federal income tax purposes, and thus no income tax expense has been recorded in the statements. Income from the Company is taxed to the members in their individual returns.

Concentration of Market Risk:

The Company maintains cash balances in its bank and at other financial institutions which, at times, may exceed the limits of the Federal Deposit Insurance Corp. (FDIC).

These financial statements were approved by management and available for issuance on January 12, 2023. Management has evaluated subsequent events through this date.
