**Executive Director:** Do I hear a motion to suspend the regular order of business and go into a public hearing for the purpose of the Annual Plan?

**Executive Director:** In relation to the Annual/ 5 Year Plan, I'll just go over very quickly. This is a requirement of HUD that we put out a 5 Year Plan and update it annually. This is what we would be proposing to send to HUD from the physical end items that we have included are elevator modernizations at Kill Van Kull, kitchen and baths at various sites, Authority-wide vacuum pumps, booster pumps, water main repairs, peaked roof repairs, walk-up hallway lighting, lobby upgrades, automatic doors in senior buildings, crawl space cleaning, electrical work at the walk-ups vs the high-rises, upgrade the garbage compactors, flat roof replacement, window replacement to various sites, boiler upgrades, hot water heater upgrades, tree trimming, and fire-escape upgrades at the walk-ups. We were notified last week that the budget for next year is \$3,142,853, which we're very happy with. We thought it was going to be less. We're not holding hope that we'll be at this level next year but we can always hope.

In relation to the narrative end of the plan, we want to continue to explore new housing opportunities within the community, research the rad program and make any appropriate applications and take any appropriate actions, submit a demolition disposition application for the parking lot at NJ12-3 for the purpose of partnering, selling, or development of that portion of the property, not the residences, this is empty property. Acquire and/or otherwise effectuate land and/or buildings for the purpose of housing the BHA administrative office or any other required offices. And to review and update the Live-In Aide Policy.

At this point, the meeting is open to the public. The Commissioners, the staff, if there's any questions in relation to the Annual Plan update. Hearing none, do I hear a motion to close the hearing on the Annual/5 Year Plan?

- **Executive Director:** For this portion, I know we have some appeals. Are there any non-appeals to the Board? Comments or statements or concerns that someone wants to address us with? Just state your name, where you're from.
- Harriet Weening: Harriet Weening, 535 Avenue A. Just a question again, parking is a problem. As I understand it, the Housing Authority gives out no temporary permits. Is that true?

Executive Director: Temporary permits, no.

- Harriet Weening: Okay because there's someone I'm going after. They have a nicely printed big computer sign saying "Bayonne Housing Authority Temporary Parking" and it's been there over a month.
- **Executive Director:** Please let us know. Ray Skalski is our Director of Security. If you can give him some information. While we absolutely take that seriously, we don't really have the staff to proactively go out and check for stickers. Also, at your building, there's so much traffic going in and out because of home healthcare workers and food deliveries and things, it's a little difficult. That, however, is a flagrant affront to what we're trying to do, because we do have stickers for the residents and our residents are our primary concern. Visitors, with all due respect, are not. We try to make sure as much as we can and we know there's little back and forth with the other properties nowadays.

Harriet Weening: I understand that but that car has not move in over 4 weeks.

**Executive Director:** Ray will deal with that and we are not expecting to see you back next month because it will be gone or taken care of. But if you see that it does come back, please give Ray a call after he gets a chance to look at it.

For the 2<sup>nd</sup> part of the portion of the meeting, we have appeals to the board. Since they are appeals that involve personal information, do you want it on the record or off the record? On the record means that it will be in the minutes, it will be published, it will be on the internet. You have a choice of not doing it that way, in a closed session with the representation of the Board, and your information will remain private. So what would you like?
