Demand is high, and the number of spaces is limited. We only have units available when someone moves out. So it does take time after applying to get it. But the most important thing is that you do have an application in and keep us updated with changed in your information so we can get ahold of you. As your name progresses, you will be called in as your name gets to the top of the list and process your information.

Kevin Hennesey: I was forced to take an apartment. It's very expensive.

John: One of the preferences we mentioned is paying more than 50% of your income on rent and it sounds like you are more than doing that and that will put you in a preference category. The most important thing is to have your application in.

Kevin Hennesey: Let me just check and make sure. I appreciate your assistance.

Nolfo: Make sure you keep in touch.

John: We wish you luck and hope to see you soon.

Ava Mitchell: Mr. Hennesey, if you stay there, after the meeting I'll go check the system and see if you're in there.

Kevin Hennesey: You can adjourn the meeting.
